

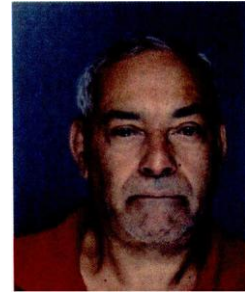
## Offender Details
