The information provided is in accordance with New York State Correction Law, Article 6C, Sex Offender Registration Act. You may refer individuals to the New York State Division of Criminal Justice website (www.criminaljustice.ny.gov) and the New York State Sex Offender Registry Information line, at 1-800-262-3257, for additional information about the Sex Offender Registration Act.

The law protects you from liability unless the information is disseminated with gross negligence or in bad faith. It is illegal to use this information to commit a crime against the above person or to engage in discrimination or harassment.

All Level Information

NYS Corrections Law allows law enforcement to make community notifications on Level 1 by zip code only. Community notifications on Level 2 & 3 offenders will include the offender's exact street address. You may access offender information on the New York State Offender Registry Website at www.criminaljustice.ny.gov.

*Level 1 offenders include name, date of birth, photograph, residence zip code, along with offense description and special probation or parole conditions. They are not listed in the Sex Offender Subdirectory on the Division of Criminal Justice Service public website.

*Level 2 & 3 sex offenders will have the same above information and are included in the Sex Offender Subdirectory on the Division of Criminal Justice website. The exact residence of level 2 & 3 offenders will be listed. Employee addresses (if available) will also be listed.

To inquire about specific offenders, you may contact the New York State Division of Criminal Justice Services Sex Offender Registry at 1-800-262-3257. You must supply the offender's name, as well as another piece of identifying information such as a date of birth, address or social security number.

You may also obtain information about registered offenders and Megan's Law by contacting the Megan's Law Helpline at 1-888-689-2672 or at www.parentsformeganslaw.org.

Offender Details Domiciled

Access to New York State Sex Offender Registry information is governed by Correction Law Article 6-C. Pursuant to Correction Law Section 168-b (2)(e), no information in the Registry shall be made available except in furtherance of the provisions of the Sex Offender Registration Act (SORA). Access to Registry information through eJusticeNY is allowed solely for Registry purposes. The information contained in the Sex Offender Registry through eJusticeNY should not be shared with the public. Unauthorized release of Registry information is a crime. Anyone who uses this information to injure, harass, or commit a criminal act against any person may be subject to criminal prosecution.
